- 6. The successful bidder shall be required to submit the amount of Rs.1 Lac as security deposit before entering into the agreement.

- 2. The successful bidder shall be allowed the use of a kiosk at Nalban Food Park (water facilities).
- 3. The selected agency shall be required to do all the interior decoration of the kiosk as may be necessary.
- 4. The Corporation shall not be responsible for the payment of any taxes that may be attracted for the sale of the food items by the agency.
- 5. The agency shall have to sell all items only within the kiosk. No vending outside is allowed.
- 6. The reserve price for the monthly rent of the kiosk has been kept at Rs.5,950/-per month excluding taxes. A license agreement will be entered into with the selected bidders for a period of 1 year which may be extended upon mutual consent of the parties. The highest bidder above the reserve price will get the opportunity to have the stall on rental basis
- 7. Sealed bids, completed in all respects must be dropped at the Bid Dropping box kept for this purpose.
- 8. The bidders must submit the following documents:

  - c. Quotation for monthly rent offered.
