

ENLISTMENT OF SEED SUPPLIERS FOR QUALITY FISH/SHELL FISH
SEED FOR SFDC LTD.

Sealed applications are invited for enlistment as a quality fish/ shell fish seeds suppliers with the State Fisheries Development Corporation Ltd. for a period of one year w.e.f. April, 2018 - to March, 2019. The prescribed proforma for application, terms and condition etc. may be collected from this Corporation office at Bikash Bhawan, Salt Lake, Kolkata-700091 between **11am to 3pm** on and from **22.03.2018**.

Different Fish spawn/ fry/fingerlings shrimp supplier by the Accredited Hatchery owners/ Post larvae producers/Co-operative Societies/related Registered Association engaged for trading may apply for the enlistment. One supplier can apply for maximum two Categories. Priority should be given to the Govt. Regd. Accredited Hatchery owners with seed certification facilities and who are supplying fish/shrimp seeds to State Govt/Central Govt. /ICAR organizations.

The culture pattern of SFDC is divided into three categories depending upon the types of culturable species in different projects of SFDC.

The details of the categories are given below:-

"A" Category: Freshwater Species - Rohu, Catla, Calbasu, Bata, Tilapia [*O.mosambica*], Nilotica (*O.nilotica*)

"B" Category: Brackish water Species - Bhangon [*Mugil cephalus*], Parse [*M.parsia*], Corsula [*R.corsula*], PCR tested Tiger shrimp PL(*P.monodon*), Chapra Chingri PL(*P.indicus*), Horne Chingri PL(*M.monoceros*),etc.

"C" Category: Diversified High Yield Species -

- i) **Freshwater** - Pangash (*Pangasius sutchi*), Monosex Tilapia, Sarpunti, Pabda (Ompak pabda), Vietnam Koi, Sol(*Channa straitus*), Deshi Magur (*C.batrachus*),Singhi(*H.fossilis*) Gulsa Tangra etc.
- ii) **Brackishwater/Marine Species** - Seabass [Bhetki], Grouper, Nona Tangra (*M.gulio*), Milk Fish (*C.chanos*), Silver Pompano. Cobia, Mud Crab(*S.serrata*), Vannamei (*L.vannamei*) etc.

Application must be accompanied by full particulars as per enclosed proforma.It should reach to the Office of the Managing Director, S.F.D.C.Ltd, Bikash Bhawan, First Floor, North Block, Bidhan Nagar,Kolkata -700091 on or before 13.00 hrs. on 29.03.2018 with Demand Draft in favour of **"Managing Director, The State Fisheries Development Corporation Ltd"** for Rs.25,000/-(Rs.
