1. General Guidance for e-Tendering

1.1 Instructions / Guidelines for e -tenderers for electronic submission of the tenders online have been shown in Web site <https://wbtenders.gov.in>

1.2 Registration of Producers/Suppliers

Producer / Supplier willing to take part in the process of e-tendering will have to be enrolled and registered with the Government e-Procurement System.

1.3 Digital Signature Certificate (DSC)

Each producer / supplier is required to obtain a Class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders

1.4 Collection of Tender Documents

The producer / supplier can search and download NIT and tender documents electronically from computer once he logs on to the website mentioned in Clause 1.1 using the Digital Signature Certificate. This is the only mode of collection of tender documents

1.5 Participation in more than one work

2. Submission of Tenders

2.1 General process of submission

Tenders are to be submitted online through the website stated in Clause 1.1 in two folders, at a time for each work, one is Technical Proposal and the other is Financial Proposal, before the prescribed date and time mentioned in the list attached. Using the Digital Signature Certificate (DSC), the documents are to be uploaded virus scanned and digitally signed.

2.2 Technical Proposal

The Technical Proposal should contain scanned copies and/or a declaration in standardized formats of the following in two covers (folders).

Technical File (Statutory Cover) containing.

i) TENDER DOCUMENT.

ii) NIT.

iii) Earnest Money Deposit (EMD) – Demand Draft Deposit at Call Receipt towards cost of earnest money as prescribed in the NIT in the list attached, separately against the Supply of Fish Seed in different Blocks/Districts in West Bengal in favour of **THE STATE FISHERIES DEVELOPMENT CORPORATION LTD.**

3. Eligibility criteria for participation in tender:

The Bidder should be a Producer or Authorized Supplier of Fish Seed and having credential of at least 6% (Six) of the total cost of the mentioned Fish Seed items value and having experience in undertaking similar nature of work. Capability statement in separate sheet should be submitted along with the technical bid.

Bidder whose tender is accepted shall supply the full items mentioned in each supply order within maximum 15 days from the date of issue of supply order ensuring quality and description as per the tender. Supply orders shall however be placed for different Block/Districts as per the requirement of the Authority.

The Bidders are required to produce the original documents for verification by the Tender Committee as and when required.

Qualified firms will be intimated to attend the opening of Cover II (Financial Bid). The venue will be intimated separately

The intending Bidders shall clearly understand that whatever may be the outcome of the present invitation of Bids, Accepting authority reserves the right to accept /reject any/all Bid documents/offer without assigning any reason what so ever and is not liable for any cost that might have incurred by any Bidder at the stage of Bidding.

Special Note:- 1. Quoted Rate should inclusive all applicable Taxes and Duties as per Govt. Rules, Delivery Charges of Transportation at Supply site, Loading & unloading Charges of the material.

Opening of Technical Proposal

Technical proposals will be opened by the authorized representatives electronically from the website stated in Clause 2.1, using their Digital Signature Certificate.

Intending tenderers may remain present, if they so desire.

Cover (Folder) for Statutory Documents should be opened first, if found in order, Cover (Folder) for Non-statutory Documents will be opened. If there is any deficiency in the Statutory Documents, the tender will summarily be rejected.

Decrypted (transformed into readable formats) documents of the Non statutory Cover will be downloaded, and handed over to the Tender Evaluation Committee (constituted for evaluation of tenders).

Procedures to be followed when one / two technically qualified Tenderers participated in any tender

Financial bid of technically qualified single / two tenderers may not be opened immediately. 2nd call may be invited immediately after technical evaluation and uploading the list of the technically qualified bidders(s) of the 1st call. If such bidder(s) technically qualified in the 1st call intend(s) to change their rates quoted in the 1st call, they are to purchase tender paper afresh. In case of non purchase, the rates quoted in the 1st call would remain valid. After selection of technically qualified tenderers for 2nd call (in case new tender other than the existing tenderer of the 1st call), financial bid of both 1st and 2nd call would be opened. Financial evaluation would be made in a combined way considering both 1st and 2nd call. However, in case tenderer(s) of 1st call submit(s) fresh tender in 2nd call, rates of 2nd call should be considered in the process of evaluation.

Acceptance of Tender (Technically eligible/qualified)

Lowest valid rate should normally be accepted. However, the Tender Accepting Authority does not bind himself to do so and reserves the right to reject any or all the tenders, for valid reasons and also reserves the right to distribute the work amongst more than one tenderer.

Penalty for suppression / distortion of facts

SPECIAL CONDITIONS OF CONTRACT

➤ **Name of work**

Supply of Fish Seed for IMC - Rohu(60%),Catla(30%),Mrigal(10%) Under Moina Model Govt. Scheme.

➤ **PAYMENT PROVISION:**

- No advance payment towards cost of Fish Seed or for any other thing will be made to the approved Bidder.
- The Bidder should produce delivery Challan and Invoice in Triplicate for obtaining payment.
- Payment will be made to the successful Bidder on receipt of the Fish Seed in good condition at the destination point, duly certified by Departmental Technical Officer.
- Income Tax Surcharge as applicable and Sales Tax / VAT as applicable will be deducted from the Bill of Agency.
- The security deposit can only be refunded after satisfactory completion of supply of fish Seed as per contract.
- No interest shall be given on money deposited by tenderer in form of security deposit.
- No extra work beyond the scope of the Agreement shall be allowed without prior permission from competent Authority.
- The tenderer is to bear required Sales Tax, Octroi Taxes/ all other taxes and royalties etc., as applicable, at his own cost & risk.
- The minimum wages fixed by West Bengal Government from time to time are to be paid by the tenderer to the labour engaged by him in the work.
- The work should be restricted to the available funds.
- Forfeiture of Security Deposit:- Security amount in full or part may be forfeited in the following cases:-
 - When any of the terms and conditions of the contract is breached.
 - When the tenderer fails to make complete supply satisfactorily.
 - Notice of fifteen days will be given in case of forfeiture of security deposit. The decision of the Purchase Officer in this regard shall be final.
- Forfeiture of earnest money: The earnest money will be forfeited in the following cases:'
 - (a) When tenderer withdraws or modifies the offer after opening of tender but before acceptance of tender,
 - (b) When tenderer does not execute the agreement, if any, prescribed within the specified time,
 - (c) When the tenderer does not deposit the security money after the supply order is given,
 - (d) When he fails to commence/ complete the supply of the items as per supply order within the time prescribed.
- The tenderer will not claim anything in any shape from the Government if the work is curtailed or stopped at any stage for any reason. This will form a part of the contract.

➤ **NO CLAIM OF COMPENSATION FOR SUBMISSION OF TENDER:**

No Bidder shall be entitled to claim any expenses /charges incurred by him or incidental therein connection with submission of Tender

➤ **EXTENTION OF COMPLETION DATE:**

- (a) The time allowed for execution of the supply of fish Seed as specified in the Contract data shall be the essence of the Contract. The execution of the supply of fish seed shall commence from such time period as mentioned in letter of Award. If the Agency commits default in commencing the execution of the supply as aforesaid. Government shall without prejudice to any other right or remedy available in law, be at liberty to forfeit the security deposit absolutely.
- (b) In case of delay occurred due to any of the reasons mentioned below, the Agency shall immediately give notice thereof in writing to the department but shall nevertheless use constantly his best endeavors to prevent or make good the delay and shall do all that may be reasonably required to the satisfaction of the department to proceed with the works.
- Force major, or
 - Abnormally bad weather, or
 - Serious loss or damage by fire, or
 - Civil commotion, local commotion of workmen, strike or lockout affecting any of the trades employed on the work, or
 - Delay on the part of other Agency or tradesmen engaged by officer in-charge in executing work not forming part of the Contract.
 - In case a Variation is issued which makes it impossible for Completion to be achieved by the Intended Completion Date without the Agency taking steps to accelerate the remaining work and which would cause the Agency to incur additional cost, or
 - Any other cause, which, in the absolute discretion of the authority mentioned, in Contract data is beyond the Agency control.
 - Request for reschedule and extension of time, to be eligible for consideration, shall be made by the Agency in writing within fourteen days of the happening of the event causing delay but not later than the last due date of completion of work. The Agency shall indicate in such a request the period for which extension is desired.
 - In any such case a fair and reasonable extension of time for completion of work may be given with or without liquidated damages. Such extension shall be communicated to the Agency by the Corporation.
 - Extension in delivery period:- In case of extension in the delivery period with liquidated damages the recovery shall be made on the basis of following percentages of value of stores which the tenderer has failed to supply :-

- a) Delay upto one fourth period of the prescribed delivery period- 2.5%
 - b) Delay exceeding one fourth but not exceeding half of the prescribed delivery period 5%
 - c) Delay exceeding half but not exceeding three fourth of the prescribed delivery period- 7.5%

- In case of failure of delivery of Fish Seed with in stipulated time as per condition no. 27. Corporation shall be free to purchase Fish Seed on prevailing market prices. In such case difference if any shall be recovered from the due claim/ security deposit of bidder.
 - The rate offered should be written both in figures and words and no cutting or over writing shall be entertained and rate should be quoted in the prescribed form in Cover-II (Price Bid).
