## NOTICE INVITING TENDERS FOR LICENCING OF GOVERNMENT FISHERIES OF NO. 4 BHERY .

Sealed bids are invited by The State Fisheries Development Corporation Ltd (SFDC) from the Primary Fishermen's Co-operative Societies, Fish production Groups, Self Help Groups or such other agencies as recognized by Govt. for allowing permissive possession on licence basis for utilization of the water body for production of fish.

### ELIGIBILITY CRITERIA

1. The interested bidder must be Primary Fishermen's Co-operative Societies, Fish production Groups and Self Help Groups who are duly recognized by Govt. and possess due registration certificates.
2. The interested bidder should submit photo copies of registration certificates and Income Tax return acknowledgements for the last 3 financial years, as may be applicable to the agency.

### INSTRUCTIONS FOR BIDDERS

1. The Bidders shall complete in all respects the Bid Documents, quote the annual licence fees and furnish the information called for therein and shall sign each of the documents. The Bidders shall initial each page of the Bid Documents.
2. The Bid shall be signed by a person or persons duly authorized by the Bidder with signature duly attested. In the case of a body corporate, the Bid shall be signed by the officers duly authorized by the body corporate with its common seal duly affixed.
3. The Bid shall contain the address, Tel.No., Fax No. and email id, if any of Bidder for serving notices required to be given to the Bidder in connections with the Bid.
4. The Bid form and the documents attached to it shall not be detached one from the other and no alteration or mutilation shall be made in any of the documents attached thereto.

5. The Bid shall accompany the earnest money of the required amount in the form of Demand Draft/ Pay Order drawn in the name of "The State Fisheries Development Corporation Ltd" payable at Kolkata.
6. The successful bidder shall be required to submit the amount of Rs.1 Lac as security deposit before entering into the agreement.
7. SFDC LTD. reserves the right to adjust arithmetical or other errors in any Bid in the manner in which SFDC LTD considers suitable or deem fit. Any adjustments so made by SFDC LTD shall be stated to the Bidder if SFDC LTD makes an offer to accept his Bid.
8. SFDC LTD does not bind itself to accept the highest or any Bid and has the right to reject any Bid without assigning any reason whatsoever. SFDC LTD also reserves the right to re-issue the Bid.

## **TERMS AND CONDITIONS**

1. The Bidder is expected to have inspected the premises and acquainted himself with the security and other services of the premises on any working day during working hours till the last date of submission of bids.
2. The successful bidder shall be allowed the permissive possession on licence basis for utilization of the water body for production of fish at No. 4 Bheri situated at Khatian no. 1, Dag No.509, J.L. No. 65, Mouza Dhapamanpur, P.S. Bidhannagar (South), Dist. 24 Parganas (South) with total land and water area admeasuring about 600 bighas.
3. The Corporation shall not be responsible for the payment of any taxes that may be attracted out of any activity carried out by the agency.
4. The selected agency will be required to obtain all applicable licences and permits as may be necessary.
5. The selected agency shall be responsible for the security and maintenance of the entire No. 4 Bheri water body along with appertaining land. In case of any ecological damage including felling of trees, etc, the Corporation shall be entitled to claim such cost for the damages as may be reasonable.
6. The reserve price for the rent of the lawns has been kept at Rs.2,20,000/- per annum for the right to utilize the No. 4 bheri water body. A licence agreement will be entered into with the selected bidders for a period of 3 year which may be extended upon mutual consent of the parties.
7. Sealed bids, completed in all respects must be dropped at the Bid Dropping box kept for this purpose.
8. The bidders must submit the following documents:
  - a. Letter of submission of bid
  - b. Detailed list indicating the documents submitted as part of bid.
  - c. Quotation for annual licence fees offered stating.

- d. The agency will have to furnish EMD of Rs.10,000/- in the form of demand draft in favour of "The State Fisheries Development Corporation Ltd" payable in Kolkata which will be reimbursed to the unsuccessful bidders after the completion of the bid process.
  - e. Self attested photocopies of all registration documents and applicable tax registration certificates/returns.
  - f. All legal disputes arising out of this contract shall be subject to the exclusive jurisdiction of High Court, Calcutta.
9. SFDC management shall have the liberty to terminate the contract by giving an advance notice of 30 days.
